



What is a code of Practice?



A Code of Practice is a practical guide, approved under the Work Health and Safety Act 2011. It sets out how to achieve the standards required under the Work Health and Safety Act 2011 and Work Health and Safety Regulations 2011. An approved Code of Practice is admissible in court proceedings.
